On behalf of **West Wind Hospitality Inc** we are pleased to support the San Francisco Bay Oakland International Airport (OAK) Terminal Modernization and Development Project.

Local business such as ours, have been barely getting by in the past four years. A modernized airport will bring much needed traffic into our city. The Oakland International Airport is still preferrable to San Francisco Internation Airport for it's location and fares. Please strengthen one of East Bay's remaining economic drivers by moving this project forward.

OAK is owned and operated by the Port of Oakland (Port) and is the main airport for the Greater East Bay, the most populated region of the San Francisco Bay Area with over 7.7 million people across 103 cities, villages, and towns. OAK is also an economic engine for the region. It generates over \$1.6 billion in economic impact, 30,000 direct jobs, \$575 million in direct wages, and \$373 million in state and local taxes annually. Additionally, the airport generates \$2.8 billion in annual business revenue through the millions of visitors who come to the East Bay.

OAK currently has 29 aircraft gates in two aged terminals which no longer meet current industry standards and were not designed to serve the number of passengers that are projected to fly through OAK over the coming decades. Due to the age, condition, and size of the existing OAK terminals and facilities, new investment is needed to modernize OAK facilities, meet industry safety standards, and improve operational efficiency, and accelerate the environmental sustainability goals of the airport. Renovation is needed in order for innovation. OAK's ongoing environmental goals would be incorporated into the design of a new and modernized terminal facilities. This exciting project would modernize Terminals 1 and 2, consolidate passenger processing functions (e.g., ticketing, baggage check-in, baggage claim, security screening), construct expanded international arrival facilities, construct a new passenger terminal, and improve the terminal area roadway and parking areas.

The project would greatly benefit the East Bay. It would allow OAK to meet regional passenger demand, provide a world class travel experience for millions of passengers, and drive new

economic development for the region. It would increase workforce development partnerships and create thousands of construction jobs under the Port's Project Labor Agreement. In addition, the project will include local hiring preferences and small and local business utilization programs to ensure that East Bay workers and companies are directly benefiting from the project.
