**PROPOSED ACTION: Resolution:** Approve and Authorize the Executive Director to Award and Execute a Contract with O.C. Jones and Sons, Inc. in an Amount Not-to-Exceed \$29,853,150.00 for the Berths 32-33 Leveling Project; Execute Contract Change Orders in an Amount Not to Exceed \$8,955,950.00 and Finding that the Proposed Action Complies with the California Environmental Quality Act as Analyzed in the 2002 Oakland Army Base Area Redevelopment Plan EIR. **(Engineering)**

**EXECUTIVE SUMMARY:** The Berths 32–33 Leveling Project will eliminate grade changes to create a uniform pavement surface and support seamless operational continuity between the two berths. This mostly grant-funded effort will improve land-use efficiency within the Oakland Seaport and enhance the area's overall marketability.

## BACKGROUND & ANALYSIS

On June 13, 2024 the Port accepted \$119,678,000 of PFIP grant funds for projects in and adjacent to the Port's Maritime Area (Seaport). Included in these projects was leveling the grade differential between Berths 32 and 33 which is anticipated to be approximately 70% grant funded. The existing grades between Berths 32 and 33 differ by approximately four feet, with Berth 32 higher than Berth 33 over approximately 900 feet. This grade separation impacts efficient terminal operations between the two berths. The Berths 32–33 Leveling Project will eliminate this grade differential, improving operational flexibility and functionality.

The scope of the Project in general consists of the construction of new pavement, terminal lighting, drainage, stormwater treatment facilities, fencing, and all associated supporting infrastructure. In alignment with our sustainability goals, material generated from site demolition, along with the stockpiled materials along 7th Street, will be used to level the grade difference between Berths 32 and 33.

On November 3<sup>rd</sup> 2025, the Port issued invitations to bid on the Berths 32-33 Leveling Project. Port Staff hosted a pre-bid meeting and site visit on Wednesday November 19, which 25 contractors attended. On December 15, 2025, the Port received eight bids. The Bids were subject to the Port's Non-Discrimination and Small Local Business Utilization Policy (NDSLBUP). Table 1 summarizes the bids, indicates the bid discount percentages, and identifies the number of businesses that are certified Local Impact Area (LIA), Local Business Area (LBA), Small Business Enterprise (SBE) and Very Small Business

Enterprise (VSBE).

Port Staff evaluated the bids based on criteria set forth in the solicitation and determined that all bids are responsive and responsible. Based on the bids, awarding the contract to O.C. Jones and Sons, Inc of Oakland, CA is the successful winning bidder.

## OTHER FINDINGS AND PROVISIONS

### ENVIRONMENTAL REVIEW

The proposed action was analyzed under the California Environmental Quality Act (CEQA) and was found to be:

Analysis: The total Project Budget of \$45,608,800 exceeds the \$35,300,000 previously programmed for the Project by \$10,308,800 over the FY2025-FY2028 design and construction periods. The increased costs associated with the Berths 32-33 Leveling Project are being accommodated through unused grant funding that is being repurposed (subject to Grantor approval) to maintain capital affordability and align with Maritime Division's long-term funding capacity.
