



## **AGENDA REPORT**

PROPOSED ACTION: Resolution: Approve and Authorize the Executive Director to Award and Execute Contracts with Nibbi Bros. Associates, Inc., SilMan Venture Corp DBA SilMan Industries, and Suffolk Construction Company, Inc. for On-Call Building Related Construction in the Aggregate Amount Not to Exceed of \$24,000,000 Commencing September 1, 2025 and Ending August 31, 2026, 2027, or 2028; and Finding that the Proposed Action is Exempt Under the California Environmental Quality Act. EXECUTIVE SUMMARY: On-call contracts are an essential tool for performing certain Port of Oakland (Port) work. The Port has many capital improvement projects scheduled, and expense projects anticipated, for which the on-call contracts will be key to delivering on time. Port Staff recently solicited new bids for up to five on-call Building Related Construction (BRC) contractors. Port Staff seeks authorization for the Executive Director to award and execute BRC contracts in a total amount not to exceed of \$24,000,000 and for the period commencing September 1, 2025, and ending August 31, 2026, 2027, or 2028.

## **BACKGROUND & ANALYSIS**

On-call contracts are essential tools in delivering the Port's projects and programs. Each project is separately authorized by a formal work authorization with multiple layers of approval in accordance with all Port policies and best practices. Port Staff anticipates a variety of projects over the next three years including construction of roof replacements and air handler unit upgrades. To best meet these demands over the next three years, Port Staff completed a formal procurement process for these services.

On April 28, 2025, the Port issued invitations to bid on on-call BRC contracts. On June 10, 2025, the Port received five formal bids for BRC contracts. The bids were subject to the Port's Non-Discrimination and Small Local Business Utilization Policy (NDSLBUP). Table 1 summarizes the bids, indicates the bid discount percentages based on the NDSLBUP, and identifies the number of businesses that are certified Local Impact Area (LIA), Local Business Area (LBA), Small Business Enterprise (SBE) and Very Small Business Enterprise (VSBE).

Port Staff evaluated the bids based on criteria set forth in the solicitation and determined BBI Construction was not responsive due to the omission of a required document and that all other bids are responsive and responsible. Port Staff recommend the three lowest bidders for award and contracts.
