

#### **AGENDA REPORT**

PROPOSED ACTION: Resolution: Approve and Authorize the Executive Director to Enter into a Professional Services Agreement to Provide Community Engagement Support and Facilitation Consulting Services with: (1) RDA Consulting, SPC for the Clean Ports Program for a Total Combined Amount Not to Exceed \$600,000 for a Term up to Five Years with an Option for Two One-Year Extensions; and (2) InterEthnica for the Clean Heavy-Duty Vehicles Program for a Total Combined Amount Not to Exceed \$50,000 for a Term up to Three Years with an Option for Two One-Year Extensions; and (3) Civil Edge Consulting, LLC for Other Potential Federally Funded Projects for a Total Combined Amount Not to Exceed \$300,000 for a Term up to Three years with an Option for Two One-Year Extensions; and if Negotiations with the Above Firms are Unsuccessful, to Execute a Professional Services Agreement with the Next Three Highest Rated Firms (4, 5, and 6), for a Maximum Compensation Not to Exceed \$600,000, \$50,000, and \$300,000 Respectively; and Find that the Proposed Action is Exempt Under the California Environmental Quality Act. **EXECUTIVE SUMMARY:** In October 2024, the Port of Oakland (Port) was awarded two Environmental Protection Agency (EPA) grants; the Clean Ports Program – Zero Emission Technology Competition (Clean Ports) award for \$322 million, and the Clean Heavy-Duty Vehicles (CHDV) grant award for \$10.5 million. These grants include the participation of Community Based Organizations (CBOs) to carry out various community engagement components of the grant. Consulting services to support the work of the CBOs were anticipated and included in the project budgets for these two

programs. Following a competitive solicitation for community engagement support and facilitation consulting services, Por staff is recommending the highest ranked firms, RDA Consulting, SPC for the Clean Ports Program, InterEthnica for the CHDV grant, and Civic Edge for future potential federally funded projects.

## **BACKGROUND & ANALYSIS**

#### **Federal Grant Information**

Clean Ports Program. The EPA awarded the Port of Oakland \$322 million to fast track the Oakland Seaport's conversion zero-emissions cargo handling operations. The Port's historic and transformative proposal is called "Community Led, Business Supported, Proven and Ready to Go! Transforming the Port of Oakland to Zero Emissions." The grant is intended to finance 663 pieces of zero-emissions equipment which includes 475 drayage trucks and 188 pieces of cargo handling equipment. The project also includes the following program elements: Community Engagement, Fence-line Air Quality Monitoring Program, Workforce Development, and a Trucker Loaner Program.

The Port partnered with four CBOs to further deepen engagement opportunities: Black Cultural Zone Community Development Corporation (BCZ), Rose Foundation for Communities and the Environment (Rose Foundation), West Oakland Cultural Action Network (WOCAN), and West Oakland Indicators Project (WOEIP) to engage other CBOs and Oakland residents to participate in project activities including monitoring and informing the community on the performance of the Project.

Clean Heavy Duty Vehicle Program at OAK (CHDV Program). The "Empowering Delivery for Tomorrow: Port of Oakland and UPS Transition to Battery Electric Trucks Serving Bay Area Disadvantaged Communities" project will replace 60 Class 6 UPS delivery trucks with zero-emission battery electric delivery trucks and install supporting charging infrastructure at three different logistics centers in the Bay Area including: 40 trucks and chargers adjacent to the Oakland San Francisco Bay Airport (OAK); 10 trucks and chargers at the San Francisco UPS facility, and 10 trucks and chargers at the Richmond UPS facility.

The Port partnered with two well-regarded CBOs for this project to improve its outreach to disadvantaged communities. Black Cultural Zone Community Development Corporation and Lifers Leaving a Legacy were selected as partners based on their competency and dedication to disadvantaged communities including work with individuals with limited-English proficiency (LEP), as well as proven experience working on issues such as public health, health equity, environmental health, environmental justice, social justice, racial equity, youth development, and senior services

Through projects such as these, the Port is supporting building the capacity of these CBOs to serve community needs and act as a conduit between agencies like the Port and individuals in disadvantaged communities. Community engagement consulting services will support the work of the CBOs to achieve grant deliverables and timelines.

**Additional Potential Federally Funded Projects.** The Port reserves the right to add additional federally funded projects that support the Port's commitment to environmental sustainability and its zero-emissions operations goal, as the Port secures them under this contract for community engagement support and facilitation consulting services.

## **Community Engagement Support & Facilitation**

The Port's Social Responsibility Division, in coordination with the Environmental Programs & Planning Division, sought highly qualified consultants to coordinate and oversee the community engagement deliverables of the partnering Community-Based Organizations. This includes the following: development of a comprehensive community engagement and communications plan; community engagement support, facilitation and logistics of meetings and activities; creating informational and educational materials on the subject matter (flyers, info graphics, presentations, etc.); and grant administration support, including the oversight of community engagement deliverables.

On March 28, 2025, the Port Purchasing Department released a formal Request for Proposal (RFP No. 24-25/10) titled Community Engagement Support and Facilitation Consulting Services for Federally Funded Projects. The Port held a non-mandatory preproposal meeting on April 11, 2025, with 38 attendees from various organizations. The Port received 10 proposals on May 8, 2025. To evaluate the proposals, the Port established a three-person Evaluation Panel consisting of three Port Staff from the Social Responsibility, Environmental Programs & Planning, and Maritime Divisions. The Evaluation Panel scored the 10 proposals based on the following criteria set forth in Table 1 below:

The Port's Non-Discrimination and Small Local Business Utilization Policy (NDSLBUP) was not included in the evaluation criteria because the contract will be federally funded, which prohibits local preference points.

Based on these criteria, the Port recommends awarding the highest scoring firms, InterEthnica, RDA Consulting, SPC, and Civic Edge as shown in Table 2. These three firms demonstrated the following in their qualifications and interview: 1) Participatory planning, Consensus building, Conflict mitigation, and Public Speaking experience; 2) Local ties, knowledge, and cultural competence collaborating with stakeholders of the Port's Fence-line communities including Oakland (particularly West Oakland and East Oakland), Alameda and San Leandro; 3) Engagement with Environmental Justice communities; Bay Area Native American population, low-income communities, communities of color, individuals with Limited-English Proficiency (LEP), including grass-roots Community-Based Organizations and 4) Community development and working on topics such as air quality, public health and health equity, transportation and freight, land use, environmental justice, climate change, racial equity, youth development, and senior services.

Based on the evaluation criteria, the firms were ranked as shown on Table 2. Port Staff held interviews on June 24, 2025, with the top three consultant teams. Based on the criteria set forth, InterEthnica, RDA Consulting, SPC, and Civic Edge were ranked the top three firms.

The contract with RDA Consulting, SPC will be awarded for up to \$600,000 for a Term up to 5 Years with an Option for Two One-Year Extensions; The contract with InterEthnica will be awarded for up to \$50,000 for a Term up to 3 Years with an Option for Two One-Year Extensions; and the contract with Civic Edge for a Term up to 3 years with an Option for Two One-Year Extensions. This value was determined by considering the amount budgeted for grant administration consultant support in the respective Clean Ports and CHDV project budgets, with additional contract value for future grant administration and implementation support, if needed. Funding will be provided through the Clean Ports and CHDV grants, future federal grants, as well as Port cash.
