BRIEF DESCRIPTION OF PROPOSED WORK: MRG Oakland LLC proposes to improve their leased space to support their Oaklandish Retail concession and operations between Gates 25 and 26 in Terminal 2 at OAK. Improvements include demolition of the existing space and installation of new partition walls, finishes, and utilities. The Applicant or their contractor will file a Construction Safety and Security Plan (CSSP) with the Airport for approval prior to construction.

ENVIRONMENTAL: This project has been determined to be exempt from the requirements of the California Environmental Quality Act pursuant to Section 15301 (a), interior or exterior alternations involving such things as interior partitions, plumbing, and electrical conveyances.

SUSTAINABILITY: The Port Tenant will follow current Green Building and Energy Codes as enforced by the City of Oakland, as well as the construction debris recycling requirements. All materials removed from the site will be reused or recycled to the extent feasible.
