BRIEF DESCRIPTION OF PROPOSED WORK: Customs and Border Protection (CBP) monitors the scanning devices at the marine terminal entrances (RPM's). They propose to upgrade equipment at the new terminal gate to allow remote monitoring. The work includes installation of new camera and light poles, monitoring equipment, and electrical and data connections.	
ENVIRONMENTAL: This project has been determined to be exempt from the California Air Quality Act (CEQA) pursuant to Section 15301 of the CEQA Guidelines, which exempts minor modifications to existing facilities.	
SUSTAINABILITY: The project includes improvements to allow monitoring from a remote location for multiple terminal entrances to increase efficiency and reduce travel to sites. The project will comply with the CA Green Building Code for new materials, and all debris will be handled per the CA Construction and Demolition Debris Recycling regulation.
