
LOCATION OF PROPOSED WORK: 1 Airport Drive, Terminal 1

BRIEF DESCRIPTION OF PROPOSED WORK: Upgrades and improvements to the checked baggage screening equipment in the checked baggage areas of Terminals 1. The work is in eight locations in Terminal 1 behind airline ticket counters. Work includes upgrade of older CT scanners to the current models (not included in estimate), new belts and screening equipment, and installation of related electrical and data services. This project has been determined to be exempt from the requirements of the California Environmental Quality Act pursuant to Section 15301, Class 1(a), Interior Alterations.

SUSTAINABILITY: This project will follow current Green Building and Energy Codes as enforced by the City of Oakland, as well as the construction debris recycling requirements. The project is limited to equipment upgrades and no other sustainability measures are being considered outside the scope of this project.


