PROJECT MANAGER

Steve Palmer, Vice President, will continue to serve as the team leader and primary consultant for the Port of Oakland. Mr. Palmer, who has been at VSA for more than 21 years and knows the East Bay and Oakland very well. In addition to his work for the Port of Oakland, he has advocated for more than 20 years for AC Transit, working closely with Representatives Barbara Lee, Mark DeSaulnier, and Eric Swalwell. He also advocates for other airport and transportation agencies, including the Wayne County (Detroit) Airport Authority and John Wayne Airport in Orange County, as well as Santa Clara Valley Transportation Authority, Sonoma Marin Area Rail Transit (SMART), and Dallas Area Rapid Transit. He previously was the federal representative for the Port Authority of New York and New Jersey, as well as Tampa International Airport, and Sacramento International Airport.

Prior to coming to VSA, Mr. Palmer was confirmed by the United States Senate to be DOT Assistant Secretary for Governmental Affairs, the key legislative strategist for the Secretary of Transportation. Working on a bipartisan basis with the Congress over five years, he advocated for the passage of legislation such as several FAA authorization and airport security bills, the multi-year surface transportation bill known as TEA-21, the annual appropriations bill, as well as legislation affecting the airport, transit, highway, rail, pipeline, and motor carrier industries. While at DOT, he testified before the Congress and worked extensively with officials at the Office of Management and Budget (OMB) and the White House. This broad range of experience has given Mr. Palmer a unique understanding of how Executive Branch departments and Congress work and where decisions are made.

Before going to DOT, Mr. Palmer served ten years in senior staff positions on the Senate Committee on Commerce, Science, and Transportation, including three years as Staff Director of the Aviation Subcommittee, where he helped draft and negotiate several FAA Reauthorization bills.

He came to Washington, D.C. after being selected through a national competition to serve as a Presidential Management Fellow. Mr. Palmer received his Bachelor of Arts in political science from Kalamazoo College in Michigan. He earned a Masters of Public Affairs from the LBJ School of Public Affairs at the University of Texas at Austin.
